Terms & Conditions

1. General

- 1.1 These terms and conditions apply to and form part of all purchase orders issued by you ("the Purchaser") to Alternative Fuels & Energy Pty Ltd ("the Seller"), for the purchase of goods and services.
- 1.2 The purchase order contains terms and conditions which must be complied with by the Purchaser and the Seller. If either the Purchaser or the Seller does not comply with the provisions, the non-compliant party will be in default of its obligations to the respective party.

2. ACCEPTANCE OF PURCHASER ORDER

2.1 The Purchase order is deemed accepted by the Seller once an invoice from the Seller is sent to the Purchaser unless the Seller is advised to the contrary within 7 days of the purchase order.

3. PRICE

- 3.1 All prices quoted in the purchase order shall include all taxes and GST and shall not be increased, unless agreed in writing by the Purchaser.
- 3.2 Any additional delivery charges, including but not limited to, shipping, packaging, labeling, custom duties, storage, boxing and crating, with respect to which the Seller is entitled to receive reimbursement shall only be added to the Seller's invoice as a separate item when the Purchaser expressly agrees to the delivery charge by written consent.
- 3.3 Invoices shall contain the final and entire contract between the Purchaser and the Seller and shall be issued to the Customer as an acceptance of purchaser order.

4. PAYMENT

- 4.1 Full payment of the invoice by the Purchaser shall be made no later than 14 days otherwise the order and invoice shall be cancelled. The Purchaser may however, at its discretion, renew the purchase order in writing.
- 4.2 Full payment of the invoice must be confirmed prior to delivery of goods.
- 4.3 A receipt of the correctly rendered invoice shall be sent to the Purchaser after full payment is received.

5. DELIVERY OF GOODS

- 5.1 The Seller must comply with the timing, method and quantity requirements for the delivery of the goods and/or supply of services specified on the purchase order. Failure to comply may allow the Purchaser to cancel the order.
- 5.2 The Purchaser can specify in writing a later time for delivery.
- 5.3 The goods supplied by the Seller shall be suitably packed and prepared for shipment so as to secure the goods against damage, enable the lowest transport and insurance rates to be obtained, and otherwise comply with the carrier's requirements.
- 5.4 Either a delivery docket, packing note, receipt or invoice is to accompany all deliveries made, quoting the purchase order number or invoice number, quantity dispatched, description of the supplies and consignment details.

6. QUALITY

- 6.1 The goods supplied by the Seller shall:
 - a) be of good and merchantable quality;
 - b) be fit in every way for the purpose for which they are intended;
 - match any description given to the customer whether in promotional material, over the phone, in person, on a website or on labeling or
 packaging or if purchased after the review of a sample, comply in all respects with the sample and shall not incorporate any modification or
 variation without express written approval from the Purchaser;
 - d) be of a good and proper standard of workmanship; and
 - e) be manufactured using standard quality material.
- 6.2 The goods and/or services supplied by the Seller shall comply with all applicable Federal and State laws and regulations relating to the product standards and safety for the goods and/or services.

7. INSPECTION & ACCEPTANCE OF SUPPLY

- 7.1 The Purchaser must inspect the goods and/or services upon arrival and reject those that are not in accordance with the contract and notify the Seller within 7 days from the date of arrival of the goods.
- 7.2 The Purchaser may reject goods only if the goods do not comply under Clause 6 and exercise the rejection either under Clause 7.3 or Clause 7.4.
- 7.3 If the Purchaser rejects the goods pursuant to Clause 6 and the goods have not been used, the Purchaser must provide proof of purchase and the Seller must, without prejudice to the Purchaser:
 - (a) replace or repair without cost to the Purchaser the rejected goods or
 - (b) remove the rejected goods and refund payment of the rejected goods or

The costs of the Purchaser exercising either of these options shall be at the Seller's expense.

- 7.4 If the Purchaser rejects the goods pursuant to Clause 6 and the goods have been partially used including partial installation of the goods, the Purchaser must provide proof of purchase and the Seller must, without prejudice to the Purchaser,:
 - (a) provide a partial refund or repair of the goods
 - (b) comply with the terms under the Sun Lizard Australia Warranty Contract.

The costs of the Purchaser exercising either of these options shall be at the Seller's expense.

8. OWNERSHIP OF PROPERTY

8.1 Ownership of, and risk of loss of or damage to the goods, passes to the Purchaser upon delivery.

9. WARRANTY

- 9.1 If the purchaser gives reasonable notice of any defect or omission discovered in the goods after the inspection and acceptance of the delivered goods and during any warranty period, the Purchaser must organise and pay for shipment of goods to the Seller. Upon receipt of the goods, the Seller must correct that defect or omission without delay and must meet costs limited to packing and freight the goods to the Purchaser.
- 9.2 Where no warranty is otherwise specified the warranty period shall be 90 days from acceptance by the Purchaser.

10. REFUND

- 10.1 The Seller must provide a refund if the Purchaser exercises a rejection of goods under Clause 7.
- 10.2 The Seller cannot refund the goods if the Purchaser rejects the goods on, incidental to and not limited to the following reasons:
 - (a) the Purchaser changes their mind
 - (b) the goods are in wrong size or colour
 - (c) Goods or similar goods can be purchased elsewhere for a cheaper price
 - (d) The period of inspection and acceptance of the goods under Clause 7 has lapsed
 - (e) A defect on the goods was drawn to their attention before the goods were purchased.

11. TERMINATION

- 11.1 The purchase order shall be terminated if:
- (a) the Purchaser issues a written notice to the Seller within 7 days of the purchase order.
- (b) the Purchaser fails to make full payment of the invoice after 14 days of its issued date.

12. APPLICABLE LAW

12.1 The contract will be governed by and construed in accordance with the laws in force in Victoria.

13. ENTIRE AGREEEMENT

- 13.1 This contract is not assignable by the Seller without the written consent of the Purchaser.
- 13.2 No variation of the purchase order shall be binding on the Purchaser unless consented in writing.
- 13.3 The Seller and the Purchaser agree that they shall comply with all the provisions of the Privacy Act 1988 (Cth) as amended or other applicable privacy legislations.

Warranty Information

Thank you for reading the Sun Lizard Warranty Information. Please refer firstly to the Sun Lizard Installation Guide to ensure that you have followed all the correct installation and operating procedures. In particular please refer to any trouble-shooting guide which may have been supplied with the product.

If you wish to make a claim under warranty, to enable you to proceed quickly you must:

- contact Alternative Fuels & Energy Pty Ltd
- · return the goods in breach of the warranty in its original packaging to our Sun Lizard Customer Service Centre
- Provide a copy of your receipt with a copy of the Warranty Certificate

When goods need to be returned to our Sun Lizard Customer Service Centre, please ensure that the goods are packed carefully and appropriately marked as fragile to reduce any damage during transit.

It would also assist us, to ensure that the correct repairs are affected, if you provide with the goods at the time of your claim, a detailed description of the problem you are experiencing.

SUN LIZARD AUSTRALIA WARRANTY CONTRACT

GENERAL

1. The warranty is in addition to (and does not exclude or modify in any way) any non-excludable statutory rights you may have (including under the Trade Practices Act).

TERM

2. The warranty starts from the date of the Sun Lizard product's purchase and runs for the term of the warranty period as specified in the table below:

WARRANTY

- 3. Subject to clause 4, we warrant that the Sun Lizard product will be free from inherent defects in materials and workmanship for the period specified in Clause 2
- 4. The warranty ceases if:
 - (a) the Sun Lizard product was sold at an auction;
 - (b) the Sun Lizard product is repaired, serviced or interfered with (in any way) other than by us
 - (c) the Sun Lizard product is damaged by:
 - (i) normal wear and tear;

- (ii) accident;
- (iii) misuse:
- (iv) failure to properly clean the Sun Lizard product or any part (including user accessible filters);
- (v) failure to properly maintain and service;
- (vi) infestation by insects or vermin;
- (vii) incomplete or incorrect installation;
- (viii) incorrect operation;
- (ix) excessive use;
- (x) use for which it is not designed;
- (xi) use of faulty or leaking batteries;
- (xii) incorrect voltage;
- (d) the Sun Lizard product is rented;
- (e) the Sun Lizard product is used for promotional purposes, or used other than in a normal, domestic or commercial environment
- (f) The Sun Lizard product is used other than in Australia.
- 5. This warranty does not cover:
 - (a) other components not listed in Clause 2
 - (b) any accessory supplied with the Sun Lizard product (including wall or ceiling diffusers, ducting)
 - (c) third party service costs incurred through the installation of items
 - (d) components listed as requiring periodic replacement.
- 6. This warranty extends only to the original first end-user of the Sun Lizard product and is not assignable or transferable to any subsequent purchaser or end user.

CLAIM

- 7. If you wish to make a claim under the warranty you must contact us before making a warranty claim.
- 8. If we require you to deliver or send the Sun Lizard product to us, you will do so at your cost.

LIABILITY

- 9. If you make a claim under warranty, we will assume, unless you notify us to the contrary, that you will be fully compensated for:
 - (a) The repair of the Sun Lizard product by us
 - (b) The replacement of the Sun Lizard product by us
 - (c) the payment of the cost of having the Sun Lizard product repaired
 - (d) the payment of the cost of having the Sun Lizard product replaced

but not including:

- (e) payment of delivery costs to us under Clause 8 and
- (f) payment of third party service costs for reinstallation of the Sun Lizard product if the Sun Lizard product is replaced under Clause 9(b) and 9(d).

10. If we provide you with either a replacement of the Sun Lizard product under clause 9 (b) or 9(d) you immediately transfer ownership in the original Sun Lizard product to us.

RETURN

11. If we take possession of the Sun Lizard product under Clause 10, and if we provide you with a replacement under Clause 9(b) or 9(d), we will return the replacement product to the original product's delivery address at our cost unless you notify us in writing of an alternative delivery address.

NOT COVERED

- 12. Subject to Clause 1 if, after we have inspected the Sun Lizard product, we are of the opinion that the Sun Lizard product or alleged defect is not covered by the warranty for whatever reason, you will be liable for any labour, parts or transport costs incurred by us.
- 13. In this contract:

"Our Cost" means at cost, which will be paid us;

"Sun Lizard product" means the products sold to you and appearing under Clause 2 and does not include any accessories supplied with any product. "Term" means the period applying to the Sun Lizard product as set out in Clause 2. This period commences on the date of purchase of the Sun Lizard product.

"Sun Lizard Customer Service Centre" means a place and or person who carries out, among other things, repair and service work as our authorised agent and who appears in lists maintained and published by us from time to time.
